# Environmental Management System (EMS) Frequently Asked Questions (FAQ)

#### Q: How do I become a Hazardous Waste Coordinator (HWC) for my unit?

- Be appointed in writing from your unit Commanding Officer/Officer-in-Charge or applicable civilian or contractor Department/Project Lead using the template <u>HWC Appointment Letter and</u> Billet Description.
- Complete the pre-requisite training identified below, "What are the pre-requisite courses before attending the Hazardous Waste Coordinator (HWC) Course?".
- Within 3 months of appointment from your unit Commanding Officer/Officer-in-Charge or applicable civilian or contractor Department/Project Lead; sign-up for and attend the MCAS Miramar Hazardous Waste Coordinator (HWC) Course at <a href="www.MiramarEMS.com">www.MiramarEMS.com</a>, clicking on the "Environmental Training" link on the right side of the page, to learn installation-specific protocols and the operation of your accumulation site. Maintain your course completion certificate for a minimum of 3 yrs.
- Contact the MCAS Miramar, Environmental Department, Waste Management Division
   Environmental Protection Specialist assigned to your unit to receive site-specific operational
   training on your particular accumulation site.
- Attend monthly Hazardous Waste Coordinator (HWC) meetings held on the first Tuesday of each month. A calendar of meetings and training events can be found on the Home Page of www.MiramarEMS.com.
- Attend annual refresher training as required to maintain certification. Maintain your course completion certificate for a minimum of 3 yrs.

### Q: How do I become an Environmental Compliance Coordinator (ECC) for my unit?

- Be appointed in writing from your unit Commanding Officer/Officer-in-Charge or applicable civilian or contractor Department/Project Lead using the template <u>ECC Appointment Letter and</u> Billet Description.
- Complete all requirements for <u>becoming a HWC</u> to receive specific training on hazardous waste accumulation and disposition.
- Complete the station specific Environmental Compliance Coordinator (ECC) course held quarterly immediately following the ECC meeting.
- Attend quarterly ECC meetings held quarterly. A calendar of meetings and training events can be found on the Home Page of <a href="https://www.MiramarEMS.com">www.MiramarEMS.com</a>.
- Contact the MCAS Miramar ECC to gain administrator access to training records held on-line and maintained locally in the Environmental training office.
- Attend annual refresher training as required to maintain certification.

### **Q**: What are the pre-requisite courses before attending the Hazardous Waste Coordinator (HWC) Course?

- From the "<u>Home Page</u>" on this website, then clicking on the "<u>Environmental Training</u>" link. Once student registration has been complete in the MCI West Environmental Learning Management System (ELMS), the student must complete the following courses:

## Q: How can I obtain the 8056 (Hazardous Material/Hazardous Waste (HM/HW) Officer Marine Occupational Specialty (MOS)?

- Attend the MCAS Miramar Hazardous Waste Handler's (HWC) course or one of the approved courses outlined in MCO P5090.2A. The installation CETEP Coordinator finalizes the approval of all related course of instruction.
- Complete all requirements outlined in the MOS Manual http://www.marines.mil/Portals/59/MCO%201200.17E.pdf
- Consult with the Installation CETEP Coordinator for additional requirements and/or questions peculiar to your situation.
