Required Annually prior to anniversary date of initial HWC Course.

## ECC COURSE

Station specific course for New Unit ECCs

Environmental training provides MCAS Miramar personnel the tools and knowledge necessary to complete tasks safely and effectively while mitigating health risks, reducing environmental impacts and maintaining compliance regulations

Any needed scheduling changes will be disseminated as required.

## TRAINING REQUIREMENTS

Below is a list of required and suggested courses for HWC, ECC and 8056 MOS billet holders.

\*MCO 5090.2 requires HWC be trained within 60 days of assignment and appointed in writing.

\*MCO 5090.2 requires all units (Squadron and Battalion level and higher) to have MOS 8056 trained personnel.

\*HWCs: Annual refresher training is required prior to 1 year anniversary of initial HWC Course.

\*Sections 1-4: All personnel handling HM/HW, must receive HM/HW, HAZCOM and emergency procedures prior to performing their duties. This training is relevant to their responsibilities during normal and emergency operations, as required by the unit's ***Consolidate Emergency Response/Contingency Plan***. This training, known as ***Sections 1-4***, should be provided by the unit's ***Hazardous Waste Coordinator, ECC or 8056*** initially, then on an annual basis.
