ON THE AIR STATION

Recycling revenues keep the program operating and may provide excess funds to MCCA for Morale, Welfare, and Recreation (MWR) activities.

AT THE BARRACKS

Cleaning supplies can be checked out from the Facility or Sector Manager. When you're done, return them for distribution to other residents needing those supplies.

AIR STATION HOUSING

The average household contains between three and ten gallons of materials that are potentially hazardous to human health or the environment. Household cleaners, solvents, paint products, pesticides, automotive products, and many other chemicals can create health and environmental problems when disposed of improperly.



The re-use of products outside of their initial intended purpose is what the **Pollution Prevention (P2)** program is all about. It allows the user to make creative and/or other predetermined re-use of commonly used products, containers and supplies.

Be creative.

What can you come up with?

REDUCE

...the amount of **THESE hazardous products that you purchase, or purchase less toxic/potentially harmful products:**

- Aerosol cans
- Ant / rodent poisons
- Automotive fluids
- Cleaning products
- Fluorescent lamps
- Herbicides
- Insecticides
- Painting supplies (adhesives, strippers, stains, thinners, and solvents)
- Pesticides

Do not dispose these products in recycling bins or regular garbage collection. See reverse for disposal location.

REUSE

...material you already have on hand:

- Bottles and jars with lids
- Coffee cans
- Hardware
- Newspaper
- Grocery bags
- Plastic drink cups
- Prescription bottles
- Printer paper
- Take-out food containers
- Tooth brushes
- Ziploc bags

RECYCLE

...the following items in blue recycling bins or dumpsters:

- Aluminum / tin cans
- Cardboard
- Glass bottles / jars
- Magazines
- Newspaper
- Office paper
- Plastics
- Rinsed food containers
- Shrink wrap

DISPOSE

...the following items are not currently eligible for the recycling program and must be taken to the following locations:

EMD Waste Management

- Aerosol cans
- Mattresses
- Used tires

Regular Trash Receptacle

- Food contaminated containers
- Plastic picnic forks / knives / spoons
- Soft paper
- Tissues
- Napkins
